Privacy Policy Statement For Parents

Data Controller - Dan Gooch-Peters - Managing Director, Music for Life

Background

Music for Life is a not-for-profit company and is not part of any other organisation or group. We do not provide any information to third parties for selling or marketing purposes. We process personal data only when we have one of six lawful bases to do so under Article 6 of the EU General Data Protection Regulations. Most commonly, such as when someone books lessons, data is collected and processed to enable us to fulfil contractual obligations or to enable us to respond to an individual's request prior to entering into a contract for lessons.

Information we collect and why we collect it

Your Contact details

 To enable us to answer questions, arrange lessons, communicate with you about any matter related to the course, including payment for the course.

Student details

- We need to know the name of child, the school year they're in (e.g. Y5), their gender (for statistical reporting), the school attended, and any special educational needs.
- We keep a record of any further information you provide us with that you feel would be helpful e.g. previous musical experience, medical conditions.

What other information do we keep?

- We may keep emails you send us in connection with a course or activity, and we may make a
 note of any other relevant information you give us on a pupils' course record if you phone
 with a problem you want us to look into, for example. That way, we have a simple history of the
 course that will help us to meet your needs as best we can.
- We keep a record of any feedback voluntarily provided by you in order to help us deliver the best service we can.

How do we collect information about you?

- When you provide it to make a booking request through our online Booking Portal, or provide
 it in writing, by email, or over the phone when you contact us to register interest or to book
 lessons or other Music for Life activities.
- When you voluntarily provide feedback or correspond with us, for example, via email on the website or via a partial booking on the portal.
- Students may NOT provide this information and are never asked to do so.
- When you complete the ensembles registration form either via paper method, or from the encrypted 'Microsoft Forms' form that we will send directly to you.

How long will we retain information about you?

 Information provided at the time of booking the course or activity will be retained for 7 years, or as long as required to meet any legal obligations we have. After that time, all personal contact information will be erased.

- Once you have informed us you wish to cancel further lessons and all matters in connection
 with the course or activity have been brought to a close, we will not contact you further unless
 you say we can.
- Once you have informed us you no longer wish to receive booking reminders for continuing courses, or if we notice that a partial booking was made on our booking portal.

Security of Information, Data Sharing and Processing of Payment Information

- We are committed to safeguarding the privacy of our clients and website visitors. Personal details are collected via a secure, encrypted webpage and then stored in an encrypted database on a password protected server accessed by a very small number of people (just 4 as of September 2023). Please be aware that in spite of the stringent measures we take to ensure security, we cannot guarantee that unauthorised third parties will never be able to defeat the measures we have taken or use such personal information for improper purposes. You acknowledge that you provide personal information at your own risk.
- Music for Life does not store or process credit or debit card details other than the last four digits
 of your card number. Details go directly to a financially regulated card payment service provider
 (Stripe) over an encrypted webpage and are processed on our portal in a way which is fully
 compliant with the Payment Card Industry (PCI) Security Standards Council. Validation of our
 continued compliance must be demonstrated annually.
- We will share information with the card payment provider only to the extent necessary for the purposes of processing payments you make via our website, refunding such payments and dealing with complaints and queries relating to such payments and refunds.
- Where it is legally required, or necessary and proportionate for the reasonable undertaking of our contracted business activities we may share personal information with bodies such as selfemployed music tutors who we engage to provide tuition to students, schools, exam boards such as the Associated Board of the Royal School of Music, and law enforcement agencies.

Cookies

Cookies are text files placed on your computer to collect standard internet log information and
visitor behaviour information. This information is used to track visitor use of the website and to
compile statistical reports on website activity. You can set your browser not to accept cookies
and remove cookies from your browser.
